Hereby enroll my child(ren) in the Montessori Children's school (MCS), under the following terms and conditions:

Trial Period: I understand that my child is accepted for enrollment in the school on a trial basis for a period of one (1) month. If, at any time during the initial month of enrollment the school Director determines that the school is unable to meet the needs of my child, the school may terminate my child's enrollment upon a two (2) week written notice to me, and this Agreement will be terminated. Should my child attend school beyond the trial period and the school cannot accommodate the needs of my child, the Termination Policy will be initiated.

Publicity: I understand that television and radio station, newspaper and other media sources may contact and visit the Montessori Children's School. I grant permission for such interviews and/or photographs to be distributed or broadcast to the general public. In addition, I grant permission for photographs of my child(ren) to be used in any brochures, websites and informative publication describing the MCS which are distributed to the public.

Confidentiality of Records: I understand that all records which pertain to my child's enrollment in the Montessori Children's school are confidential.

Assumption of Liability and Indemnification: I assume the risk of any and all injuries, losses and damages to my child, my personal property and/or the personal property of my child which may occur in connection with my child's enrollment in the Montessori Children's School and his/her participation in the schools activities. I agree to be responsible for and will indemnify, defend and hold harmless the School against any claims, suits, judgments, losses or damages which arise out of, result from acts of my child. I accept full responsibility for my selection of the school as my care provider. I agree to indemnify and hold harmless the Montessori Children's School, Director, employees and agents from

any and all injuries, claims, losses and damages (“losses”) except to extent such losses arise out of the sole negligence or willful misconduct of the director, employees or agents.

Parent Roster: I understand that MCS will maintain a Parent Roster. This roster will contain the names, addresses and telephone numbers of MCS parents. The purpose of the roster is to assist the Director and staff in conducting School business. The list will not be distributed outside of the school and will not be used in manner inconsistent with its purpose.

I agree to pay \$_____ registration fee and \$_____ monthly tuition payment by the 1st of each month for a period of 10 months (including June _____ non refundable deposit payable at the time of enrollment) from September _____ to June _____. A Non-sufficient or Uncollected Funds fee of \$50 dlls will apply. There will be no refunds on Tuition or deposits.
